

## SAMPLE VISITATION SCHEDULE\*

The **Father/Mother** shall be entitled to exercise reasonable visitation with the minor child(ren) with the following provisions effective \_\_\_\_\_.

- A.** On every other \_\_\_\_\_ (day of week) at \_\_\_\_\_ p.m. until the following \_\_\_\_\_ (day of week) at \_\_\_\_\_ p.m.; **OR**  
The 1<sup>st</sup>, 3<sup>rd</sup> & 5<sup>th</sup> weekends from \_\_\_\_\_ (day of week) at \_\_\_\_\_ p.m. until the following \_\_\_\_\_ at \_\_\_\_\_ p.m.;

For any Monday or Friday holiday, the child(ren) will be with the parent who has that weekend.

- B.** During **ODD** numbered years (2011, 2013, etc.) the **Father/Mother** shall be with the child(ren) on the holidays as follows:

1. Thanksgiving: from \_\_\_\_\_ (time) on \_\_\_\_\_ (day of week) until \_\_\_\_\_ (time) on \_\_\_\_\_ (day of week)

- C.** During **EVEN** number years (2010, 2012, etc.) the **Father/Mother** shall be with the child(ren) on the holidays as follows:

- D.** The children will be with the **MOTHER** on Mother's Day from \_\_\_\_\_ a.m. until \_\_\_\_\_ p.m.;

- E.** The children will be with the **FATHER** on Father's Day from \_\_\_\_\_ a.m. until \_\_\_\_\_ p.m.;

- F.** The (**Father / Mother**) will have \_\_\_\_\_ consecutive/ non-consecutive (circle one) weeks to be with the child(ren) in the summer from June 1<sup>st</sup> until August 1<sup>st</sup> provided the children are not in school. During this period, the (**Mother / Father**) can have the child(ren) on the weekend directly between the two weeks from \_\_\_\_\_ p.m. \_\_\_\_\_ (day of week) until \_\_\_\_\_ p.m. on \_\_\_\_\_ (day of week). The (**Father / Mother**) agrees to give the other parent a minimum of 30 days advance written notice of (his / her) intent to exercise the summer vacation;

- G.** The primary custodial parent (**Father/Mother**) shall be with the child(ren) all other times not specifically listed herein.

- H.** Holidays shall take precedent over weekend visitation;

- I.** Visitation pick-up for the Father will be at the Mother's residence. Visitation pick-up for the Mother shall be at the Father's residence. Father and Mother agree to each bear their own transportation costs;

- J.** In the event either party is more than 30 minutes late to a visitation pick-up and does not call to notify the other parent he/she is running late; that parent agrees to forfeit his/her visitation for that time period;
